**Approval of Agenda**

Christine Zeitvogel presented the meeting agenda for approval.

Shaun Gogarty moved to approve the agenda; seconded by Jeff Chostner.

**Introduction of New Community Representative**

Christine Zeitvogel introduced new Community Representative Mike Nerenberg.

**Policy amendment to comply with the Memorandum of Understanding and State Law**

Pueblo County Attorney Sarah Long explained the need to amend the policy as follows to comply with the Memorandum of Understanding and State Law:

- a. update the number of designated community representatives on the Key Stakeholder Policy Committee
- b. change Key Stakeholder Policy Committee meetings from closed to open meetings
- c. include the location to post meeting agenda as required
- d. define the number of committee members that constitute a quorum

Shaun Gogarty moved to approve the amendments to the policy to comply with the Memorandum of Understanding and State Law; seconded by Eileen Dennis.

*The motion passed unanimously.*

### **Policy Amendment to update procedures.**

The Operational Work Group voted to approve social contact referrals via email to avoid delays. The policy was updated to reflect the process.

Shaun Gogarty moved to approve the amendments to the policy to update procedure; seconded by Mike Nerenberg.

*The motion passed unanimously.*

The group discussed the source of social referrals which must come through law enforcement. Christine Zeitvogel will forward contact information to the KSPC.

### **Law Enforcement Cover Sheet Update**

The state's evaluation team asked to add fields to the Contact Cover Sheet to capture the circumstances of social contact referrals. Local law enforcement asked for address and telephone number fields. The form was shared for information purposes only.

### **Presentation and Discussion of the Quarterly Report to be submitted to OBH**

The quarterly report covering the period of July 1, 2018 to September 30, 2018 was distributed and reviewed. There has been significant progress since September 30, including three arrest diversions and the hiring of a new LEAD attorney who will start on November 12. The report will be submitted to the state as presented.

### **Discussion of Santa Fe LEAD's 3-year report**

Shaun Gogarty prepared several questions regarding Santa Fe LEAD's 3-year report and stated that his key point was that there are approximately 1000 available Suboxone slots in Pueblo. Dr. Gogarty distributed a list of local Suboxone and Vivitrol providers; he will add Crossroads' program to the list and redistribute. He would also like to encourage Suboxone induction in the jail.

Chris Noeller reported that officers had distributed all the treatment brochures they had and have requested more brochures.

The next meeting is scheduled for Thursday, January 17, 2019, 3:00 PM – 4:00 PM, Pueblo County Courthouse, Room 333.
